- ➤ As of October 2011 we have assets of \$743765. It is divided as \$434,310 in cash and \$309,465 in equities.
- ➤ It was agreed that 5% could be used for awards in 2007. This resulted in \$37,000 being available for distribution
- ➤ Copies of the Treasurer's Report were distributed and approved
- ➤ Approximately \$32,285 was raised in the material auction, \$600 from Golf Outing
- ➤ Vic will work on some type of mailing to limited number of companies

- ➤\$500 to UW-Platteville SPE chapter.
