New Business

Discussion was had to change the foundation corporate mailing address to current President or treasurers address without actually publishing address.

Two donations totaling \$20,000.00 were made by Mark G. Sellers. \$10,000.00 is to be used as a gift and will be deposited into the foundation investment account. \$10,000.00 will be given as scholarships under Mark G. Sellers name.

A conference call was had with Julia at the Novick Insurance Group. The purpose of the call was to determine if the foundation needed liability insurance. For the annual cost of \$450.00 is was decided by the Board that it would be a good idea to have General Liability Insurance.

It was decided that we must establish criteria to handle the \$10,000.00 donated by Mark G. Sellers. Ed, Pete and Ray will head a committee and come up with criteria within 30 days.

Some discussion was had on what criteria the Board uses to decide who will receive grant money. It was determined the Foundation has sole discretion to give the money to the school of their choosing after it was determined all the criteria were met by the schools and discussion was had by the Board.

No further discussion or new business, meeting adjourned at 9:26 pm.
