10. Ad Report Jason Mallek

We've had a few new sponsors sign on. 5 have paid so far at a gold level. We've had one say they want to sign up as a silver sponsor but hasn't paid yet, Wisconsin Engraving.

The WI Arburg rep is interested in signing on as a sponsor but asked about paying a pro-rated rate. We just made a change to having sponsorships last for the calendar year... we used to have them setup as a sponsor for 12 months, starting whenever payments begin. Motion placed by Jason to prorate \$500 for newspaper ad and website monthly, but then keep all other sponsor costs as is if a sponsor pays a prorated sponsor rate. Amy second. Vote – passed unanimously.

The question was also asked whether membership is required to be a sponsor, and it's not.

Silver and gold level sponsors get one free admission to SPE Milwaukee events. We discussed out these sponsors get signed up a no charge for events... maybe a sponsorship button (pending verification) can be the easiest option to do this and add this to our current event registration process.
