# Today's Membership Realities

- The number of new members acquired will always be less than the number of lost members over any given period of time.
- We cannot, and should not, simply abandon the dues model, but we should recognize that it is not sustainable for the long term.
- SPE must become less reliant on dues revenue and more reliant on transactional income.
  - Focus on gaining "Customers vs. Members."

# SPE's HQ Membership Strategy

- Actively work to minimize the number of non-renewing members.
- Promote membership for non-members\*.
- Ensure that the gross revenue collected from "Non-Member Customers" more than replaces the revenue decline in membership dues.
